The non-compliances are for elevated suspended solids discharging to controlled waters and failure to notify NRW of these events.

We do however welcome you undertaking this monitoring data review and highlighting the misjudgements in your procedures. NRW are satisfied and reassured that the measures you have now put in place will prevent any further re-occurrence of such events.
