Site visit at GLJ Recycling with NRW officer Will Powell and GLJ Recycling representatives Colleen Andrews. Weather was cold and dry during visit, though had been raining recently.

Breaches

No breaches were recorded during this visit.

Actions since last visit

The infrastructure has been improved around the lower yard; the new concrete means that water no longer pools here.

Site visit

The waste transfer station was very full during this visit. There was a small amount of waste stored outside of the transfer station building. This would have normally been pushed in, however access to the building had been restricted to the front loading shovel by a container. The amount of waste in the transfer station needs to be reduced. GLJ Recycling will also need to produce a fire prevention plan as part of their management system that complies with this guidance. A representative from GLJ Recycling is due to attend the NRW workshop on Fire prevention.

Actions

GLJ's EMS will need updating and reviewing to including a fire prevention plan, and to also including environmental risk assessments, such as the effects of noise and vibration from their new shredder and associated plant.
