Breaches

C4 - Management - Storage, Handling, Labelling & Segregation;
breach of condition 2.3.1:

"The activities shall be operated using the techniques and in the manner described in Table 2.3 below;

1. Unless stored or treated outside as specified waste:

- a) all bulking, transfer or treatment of waste shall be carried out inside a building;
- b) all waste shall be stored in a building or within a secure container"

Small amount of mixed waste stored outside of the building, where there is less control of emissions.

Category 3 breach

Site inspection

SDAs were visibly being separated out from the main scrap pile during visit, therefore are not being shredded with the general scrap. These appliances will be taken to the WEEE treatment facility elsewhere on the yard. The way the SDAs were temporarily stored after being pulled out from the general scrap does pose a risk of being crushed by moving vehicles, therefore care must be taken to ensure the area is regularly cleared.

The waste transfer station building appeared very full, with waste stored outside of the front of the building. Waste stretched across the width of the building, though was only 2-2.5m in height. GLJ Recycling were made aware of recent fires at waste and recycling sites. If GLJ Recycling are intending to focus more of their business around the waste transfer station or wastes are likely to be stored for extended periods of time, then we would recommend more stringent fire prevention measures. This should include fire breaks, maximum stockpile heights/sizes, and regular monitoring of piles for signs of heating etc. For more information please see technical guidance note 7.01.
