Environment Officers, Nessa Dearle and Alice Sims attended site for a routine inspection and to assess the proposed storage changes. This took place on the 8th of February at 14:00.

C2 Management System and Operating Procedures:

We completed an inspection of the site, accompanied by environmental manager Keith Grubb and technically competent managers Lauren Hearne and Alison Nicholson. Thank you for taking the time to show officers around site.

During the tour of the site, the proposed changes to storage were presented to officers Dearle and Sims. It is understood that the intention is to move the flam store from the current outdoor location to the indoor waste storage area. The former space of the flam store will have empty drums and IBCs placed there.

From observations made onsite there appeared to be no issues with Safetykleen's plans for this storage move, as all infrastructure is appropriate for the purpose. As this change will not alter the activities specified in your permit, you will not require a permit variation. However, your environmental management system will need to be updated to reflect these changes.

Overall, the site appeared organised and tidy, the waste returns and hazardous waste consignment notes were up to date. Thank you for sending the updated copies of your TCM certificates, our records have now been updated with this information.
