On the 15th of October 2018 a sample was taken from the sewage treatment plant serving the Ryder Cup Clubhouse.

The analysis results showed that the permit condition for the limit on Ammonia of 10mg/l had been breached with a value of 10.8mg/l recorded.

This constitutes a category 4 breach as the value is within 20% of the upper tier, however action needs to be taken to ensure the problem does not get worse. If failures continue, further action will be considered.

On the 3rd of July 2018 Environment Officers visited site and noted the poor condition of the reed bed serving the treatment works. Whilst this is not currently part of the permit for the site, if the reed bed is required to guarantee the effluent quality it must be maintained.
