Gareth Danter-Hill and Kelly Sherratt carried out the site inspection and were met by the site director Nick Brannan and his Consultant. The weather was dry, sunny and cold.

We firstly discussed and reviewed the permit variation application that is to be submitted in early 2015. The variation is to include the increases of site boundary and the inclusion of numerous new activities on site.

The installation of a new picking line and screen has been completed and is operational.

B1 Infrastructure - Engineering for Prevention & Control of Emissions Category 4 breach of permit condition 2.1.1

This breach has been scored for the green waste that is currently being stored outside of the permit boundary and off the required infrastructure. NRW have authorised the short term storage of waste wood only within this area to help with the ease of running of the activities on the permitted site.

ACTION: Please remove the green waste from this area of the site and ensure it is placed on the correct infrastructure.

D1 Incident Prevention - Site Security Category 3 breach of permit condition 3.2.1

This breach has been scored for the continued lack of secure fencing between the site and the neighbouring yard. This issue was first brought up in August 2013 in CAR reference 30044/0187266. The boundary of the site is not only a key aspect of site security but also maintains the waste staying within the site.

ACTION: Please ensure that the concrete blocks are added to ensuring that the site both stays secure and the waste then stays within the yard.
