Tony Bruten attended site following a recent identified breach of storage and treatment of waste glass in an area other than that stipulated in the permit.

On inspection of the site I was satisfied that condition 2.1.1 was now being complied with namely all treatment of waste was taking place within a building on impermeable surface with sealed drainage and that all incoming waste was being stored within an external storage bay under canopy.

You have now complied with the requirements stipulated in my CAR form sent following my site visit on 5th May 2016.

During my visit you discussed a proposal to treat glass by crushing under the canopy area, I have considered the proposal made by you and having studied the definition of a building in the permit see below:-

- ***“building”*** means a construction that has the objective of providing sheltering cover and minimising emissions of noise, particulate matter, odour and litter.

Therefore I feel that if you were to place some plastic curtain strips to help minimise dust, odour and noise then we could consider the area under the canopy as part of the building and so there would not be a necessity for any variation of the permit.

Condition 4.3.5 of the your permit stipulates:-

- Where the operator proposes to make a change in the nature or functioning, or an extension to activities, which may have consequences for the environment and the change is not otherwise the subject of an application for the approval under the Regulations or this permit:

- a) Natural Resources Wales shall be notified at least 14 days before making the change: and
- b) the notification shall contain a description of the proposed change in operation.

I therefore feel that it will be sufficient for you to send me a letter notifying me in writing of your proposed change to operations, namely that you will be treating glass under the canopy by crushing and state that in order to prevent emissions of dust, odour and noise you will be installing plastic curtains in the section you propose using the crusher. I will put the letter in your file and will write to acknowledge the proposed change in operations.
