Site visit was to ascertain if there was any waste piles that were causing an odour and or leaching, as material was rejected from road build project.

All waste glass recycling was stored according to permit conditions, and no issues were found.

Recresco staff showed myself around the glass crushing process inside the large industrial unit. Waste glass was well segregated and crushed to a uniform particle size.

All incoming waste stored under a canopy.

No issues or breeches recorded across the site.
