An odour consistent with the material produced by Recresco was detected outside or the permitted area.

F1 - Odour - CAT 3 breach - Permit condition 3.2.1 Emissions from the activities shall be free from odour at levels likely to cause pollution outside the site, as perceived by an authorised officer of Natural Resources Wales, unless the operator has used appropriate measures, including, but not limited to, those specified in any approved odour management plan, to prevent or where that is not practicable to minimise the odour.

Large stockpile of 'eco-sand' stored on site inspected and identified as source of odour. Material had recently been disturbed and there was evidence of foul discharge leaching from the stockpile, also malodorous.

### ACTION

Please ensure that the material is managed in such away so as to minimise the risk of odour emissions. If necessary review and revise EMS storage methods and odour controls.
