4. Details of our assessment

This CAR form is in relation to a site inspection carried out on the 30th March 2022.

On the 15th February 2022 NRW received a Part A notification following a release of Biogas that was lost from the digester sludge outlet weir box on the 14th February 2022. This was as a result of a surge through digester 2. Gas was released around 1030 hrs. Approximately 1200 m³ of biogas was released within the first two hours with a further 2500 m³ released up to approximately 1900 hrs.

A number of immediate measures were taken to return operations to normal as a result and also further work has been identified to prevent future re-occurrences. DCWW have set up a project to manage and oversee the cleaning of the mixers in the digestion tanks on site to try to improve efficiency and reduce the risk of further foaming events.

Each digestion tank has two mixers and prior to my visit one of the mixer had been removed and cleaned with the remaining due to be completed by the end of Summer 2022. The mixer which has been cleaned had two blocked nozzles and since cleaning there has been an improvement in its efficiency.

There are also a number of other improvements planned for Five Fords as a result of the Biogas releases which were discussed during the meeting. Please keep NRW updated on the progress of this project and when the improvements are fully completed.

ACTION: Submit the Part B notification for the above Part A by the 25th May 2022.

Following the meeting a site walkover was undertaken. The emission points in the permit were viewed as well as the digestion tanks, biogas enclosure and MCP.
