Environment Officers Alice Sims and James Matalynski visited 1st Choice Vehicle Dismantlers (Permit Number - GP3095FF) to conduct the Depollution Audit Check List relating to the End of Life Vehicle Regulations 2003.

They were met on site by company owner, Malcolm Harrison, who provided a tour of the site alongside demonstrations of some depolluting techniques on a black Ford.

At time of arrival Mr Harrison was in the process of removing the air conditioning gases from the car using a new machine that allows him to extract the gas from one car and input it into another. After he was finished with this process he showed Officers Sims and Matalynski the outside area where the depolluted vehicles are kept.

They were stacked no more than two cars high, on a hard standing and arranged in an orderly fashion. Depolluted engines and tyres were also stores upon this surface. Within the area where depollution occurs, is a concreted surface which has drains leading to an interceptor system. This extended to inside the garage, where spill kits were also stored. These measures ensure that Mr Harrison and his team are able to effectively clean up any spillages that occur.

When discussing the destinations of waste materials created from the depollution process, Mr Harrison explained that much of the material was recycled through his adjoining garage. These included air conditioning gas, screen wash, fuel and hydraulic oils. Any hydraulic oils that are not in suitable condition to be reused are sent to Avista Oils.

The oil filters are sent to SafetyKleen, the catalytic converters to Newbury Metals and the wheel balancing weights to Bayliss Metals, all for disposal. Mr Harrison explained that normally he would leave the shock absorbers sealed and sell them privately.

Overall, the dismantled components of the vehicles were organised and stored correctly. Operations of the site all appeared to be in compliance with permit.
