This was the first introductory meeting since the issue of the permit EPR AB 3297TQ - purpose of visit to review EMS, site infrastructure and operations.

TXO Systems have in place a comprehensive management system and are operating to ISO 14001 Certified EMS and ISO 9001 Certified QMS. Training records demonstrate staff are aware of their environmental responsibilities.

All WEEE instrumentation / end of life equipment and materials stored and dismantled inside main the operational building. No oils or fuels stored on the premise and yard drains to mains foul sewer. All infrastructure relevant to process is sound and robust.

No issues noted during visit: TXO Systems operate to very high standard in line with the EMS and QMS.
