Alex Bowder attended site on Wednesday 4th January 2017 at 14:00 to conduct a routine inspection of SL Recycling Ltd, Unit 9 Penallta Industrial Estate, Hengoed, CF82 7SU. Met with director Mr. Stacey Lewis who accompanied me around site. The weather was cold and dry.

Site TCM Becky Tucker is in the final stages of competing her WAMITAB qualification. The business sent their Environment Management System to NRW last year, thank you for producing this so promptly. As discussed on site the document is currently very comprehensive covering all aspects of the business; it could be more beneficial to concentrate on the environmental aspects that NRW would be focussing on.

The business has correctly completed its waste returns document for last quarter with the relevant EWC codes. Please continue to keep up this good habit of submitting the returns document on time.

As mentioned on the last report, your permit states that the total quantity of waste accepted at the whole site shall not exceed 6,000 tonnes in a year. Be mindful of this when approaching the 12 month mark as a permit variation might be required to increase the throughput allowance.

No breaches/issues observed at the time of inspection. No issues apparent with drainage/infrastructure on site. Amount of waste on site allowed by permit - it was mentioned that the machine shears were broken which had held up the metal processing on site.

Site generally in good condition, non-ferrous metals separated in bay units.
