Penhesgyn Landfill Site Annual Monitoring Review (AMR)

February 2021 to January 2022 inclusive

The AMR was submitted to NRW as it is an annual permit requirement under the following condition:

4.2 Reporting

4.2.1 The operator shall send all reports and notifications required by the permit to Natural Resources Wales using the contact details supplied in writing by Natural Resources Wales.

4.2.2 A report or reports on the performance of the activities over the previous year shall be submitted to Natural Resources Wales by 31 January (or other date agreed in writing by Natural Resources Wales) each year.

NRW has reviewed the AMR and make the following comments. Please respond in accordance with requirements where necessary:

5.0 MONITORING ISSUES

Gas perimeter boreholes BH03, BH13 and BH06 are non-functional and are due to be replaced

ACTION: Please submit deadlines for replacement

The re-location of BH 22 has now been completed and should be integrated into the permits monitoring schedule as defined.

BH 08/88 has been lost and will not be re-instated as there are enough monitoring points to satisfy the closure requirements of the Landfill Directive.

6.2.3 Monitoring of landfill gas in perimeter boreholes.

Gas BH 14 and 18 had maximum methane levels of 25.8% CH₄ and 3.3% CH₄ respectively which are breaches of permit. Please ensure the following actions are completed for these boreholes in 2022/23:

ACTION: Report any such breaches via a Schedule 5 Part A notification with assessment and actions (if any) via part B of this form. This notification should be submitted immediately as specified in the schedule.

ACTION: Any further follow up actions from risk assessment should follow within 7 days of the initial breach.

7.1.2 Leachate Monitoring Schedule

The variable leachate levels recorded in Area 3, cell 2, were in the range of 1.69-4.56 m leachate head with a maximum of 2.8 in cell 3. Permit limits are 2m head. Please note the following actions

ACTION: Report any such breaches via a Schedule 5 Part A notification with assessment and actions (if any) via part B of this form. This notification should be submitted immediately as specified in the schedule.

ACTION: The re-circulation strategy will be reviewed by the end of Q2 2022 with a view to determining the issues with surface water or groundwater ingress

8.1.3 The sources of ammoniacal nitrogen breach are likely to be attributable to intrusions from the unlined landfill. It is not possible to take any action to reduce these breaches as a consequence of plumes from the original dilute and disperse unlined landfill. Some impact from upgradient agriculture is also suspected.
