4. Details of our assessment

Richard Stroud, business manager of Cenin Ltd, notified Lewis Evans of Natural Resources Wales (NRW) of incorrect Waste Return forms that were submitted from October 2020 to April 2022.

The waste that was missed in the returns were EWC 10 01 03 (Fly Ash from peat and untreated wood). This waste code can be accepted onto site as per Schedule 2 of Cenin's Environmental Permit (EPR-SP3936TL).

Cenin have been recycling and processing the 10 01 03 material regularly since October 2020 to manufacture their products. The error and missing data was found during a recent internal audit and as a result notified NRW as soon as possible on the 13th April 2022.

The error was due to no waste transfer notes being issued by Drax. This has been brought to their attention and will now be resolved as soon as possible. As a result of no transfer notes being produced, staff at Cenin did not believe the product was a waste as the product was purchased from Drax. Cenin, have now highlighted the issue with Drax and will be receiving transfer notes from now on.

An action in this CAR was going to be for Cenin to submit to Natural Resources Wales of updated waste returns for the quarters that were incorrectly submitted, but this was submitted on the 13th April 2022 and therefore the action was not required.

However, the PRTR submissions will need to be updated with the updated wastes.
