Review of information supplied by Matthew Richards, BAM Nuttall. Site not visited.

The permit was issued on 08 May 2014. A surrender application has now been submitted.

Waste returns have been completed for Q3 and Q4 of 2013 and Q1, Q2, Q3 and Q4 of 2014. A total of 23,460 tonnes of waste was accepted to site. Waste acceptance had stopped before 2014 and prior to the permit being issued.

Ten different waste transfer notes have been provided for incoming waste between 21 August 2013 and 17 October 2013. Waste was imported from Bryn Quarry and Penderyn. All waste was described as fill and classed as ewc 17 05 04 (soil and stones).

Document ref BBN0170:AP090 Rev A is the overall management system for the development. It includes waste acceptance procedures and checks, monitoring for dust and procedures for oil and fuel leaks.

Drawings of final levels have been provided to comply with condition 2.1.5 of the permit. Levels in line with proposed finish levels given in waste recovery plan.
