Environment Officers Elizabeth Felton and Natalie Wrangham met with Site Manager Dan James to discuss the response and measures put in place following a pollution incident in the late summer. The root cause of the incident has been traced back to the management system and a lack of maintenance regime for the lagoons. The polishing ponds have been maintained - dredged, repaired and are now working as originally designed, with balance boards splitting the flow equally between both ponds. The management system for the site has been improved with the addition of a water management section.

The catch pits installed earlier in the year to help manage surface water are working well, and are being checked/emptied daily by the gully sucker. This is recorded on a log sheet and forms part of the management system.

Continued maintenance to the lagoons and the catch pits will reduce the risk of pollution reoccurring.
