Veolia Waste Recycling Visit – 10/04/2018

Environment Officers Craig Coleman and Adam Ward completed a visit at Veolia's waste transfer station at Treforest Industrial Estate on 09/04/2018 to complete an information gathering exercise to assess the impact that the Chinese ban on waste products has affected waste operators within Wales.

China Waste Exports Checklist

This assessment involved questioning the TCM, Mr Robert Hughes about how Veolia had adjusted their business and working methods to accommodate the ban. Mr Hughes confirmed that Veolia did export waste from their facility to China, but that it was only old corrugated cardboard (OCC). Veolia were not exporting to any other countries currently. A small amount of paper was kept on site, but it was sold internally. Brokers used were MLM and Mark Lindon. Their agreed maximum contamination percentage for export to China was 0.5%, but sampling for their waste came in at 0.1%. The waste was covered by their Annex 7 VII forms.

Fire Prevention and Mitigation Plan

The sites permit does have a fire permit condition, but no fire prevention plans were in place yet. It was discussed that in the future an audit would take place focused on the facilities fire mitigation protocols, including fire risk management techniques which we require Veolia to submit. We will also be sending guidance to help ensure that the site meets NRW fire prevention and mitigation plan requirements.

Other Comments

Following the meeting regarding the China export ban, Mr Hughes showed me around the facility. All the waste being stored had been sorted and bailed prior to being exported. No breaches were recorded during this visit.
