Your operation consists of an ELV site for scrapped cars.

The parts of the permit that were reviewed were;

C2 – General Management: Management system & operating procedures

Permit Condition 1.2.2 - Vehicles are to be de-polluted as per the Schedule 5 ELV regulations, which specifies depollution to be undertaken in a covered area. NRW are pleased that this is being undertaken currently at site.

Other issues,

B3 – Site drainage engineering (clean and foul)

No interceptor known to be on site. NRW and Vauxbits to research into the drainage issues on site and arrange timeline to sort out issue.

Non-Payment of fees has been brought to my attention after the completion of the site inspection. Hopefully these have been rectified at the time of writing, but the issue of changing the name on the permit has been raised. Plans have to be started to arrange for this to happen and to change from Barry Coppen and Heather Evans to having Steve Bishop named on the Permit. (*Standard fees for this will apply and are currently set at £1999)

Noise and Odour were considered, and found to be of no concern. The conditions were overcast but dry.
