Discussed ongoing WAMITAB training being carried out by Talk Training on arranged course which is due to conclude in November 2017. Certificate to be forwarded when received.

Discussed disposal of waste tyres. SB explained that most of the tyres were sold as part worn either with or without wheels. All defective tyres were being stored in a container bulking up for disposal to minimise cost. Details of company taking the defective tyres to be supplied when next load sent away. Very small number of tyres are actually defective.

No vehicles were being stored higher than two high and so no issues with storage and handling. All depollution being carried out in building with sealed drainage.

No permit breaches identified at time of inspection.
