Site officers Laoni Tye and Kelly Sherratt visited Tynewydd Landfill on the 17th of December 2014 to conduct a site inspection. There were some breaches of the permit conditions that are outlined below.

B2 Closure and decommissioning

For sites that are closed, it includes non-compliances related to unsatisfactory decommissioning of equipment or residual contamination, or failure to maintain pollution control measures.

Schedule D Operations. Permit condition D41 states 'Working flanks and faces shall be compacted for form gradients not steeper than 1:3'

The site operator is required to survey the flanks and batters to justify that the gradient is no steeper than 1:3. No evidence of this has been submitted to NRW. **Category 2 breach.**

Schedule D Operations. Permit condition D42 states 'Each layer of waste material shall be laid to a fall to encourage water run off from the tipping area'

Whilst on site the site officers saw that there were large pools of water standing on the waste landfill.

Schedule F Site Restoration. Permit condition F49 states 'on cessation of operations the license holder should initiate the surrender procedure by notifying the Waste Regulation Authority (NRW) of the intention to surrender the Wastes Management Licence. The license holder must then comply with the Waste Regulation Authority's (NRW) established post closure monitoring regime.

The permit has not been surrendered and a post closure monitoring regime has not been agreed.

The operator will need to apply to surrender the permit and submit in writing a post closure management plan for approval by NRW no later than the 2nd March 2015.

Landowner access

All access to the site must be arranged between the operator/tenant and landowner.
