4. Details of our assessment

We received 4 reports of dust and noise emanating from the site, one of which was marked as a duplicate

report, received on the 31st March 2022 which were logged as references 2202402,22403 and 2202405. Officer Adam Evans attended the site and the receptors to the West of the site, no pollution from dust or noise was substantiated off site.

Officer arrived at the receptors to the West of the site at 14:30, no noise could be detected. The officer then went to site and met with Simon (site supervisor) and Carl Holder (site manager). The screener and crusher were turned on and the officer returned to receptors to the West, the noise was barely auditable and was deemed not to be having an impact. No dust could be seen blowing on site or emanating off site. The officer discussed this with the site manager at the time and left site at 15:20.
