4. Details of our assessment

Following late and incomplete submission of the annual reports for 2021, Western Power Distribution (WPD) were required to complete the following actions to ensure that future reports were submitted on time, containing all the information required by the permit. All the actions were to be completed by 22nd April 2022.

A response was received on 19th April 2022 and is accepted.

Action A1: Ensure all relevant personnel fully understand permit requirements and have easy access to a copy of the permit.

Action C1: Improve training regarding permit compliance.

Permit requirements have been explained to relevant personnel and they have access to a copy of the permit. Compliance will be monitored via monthly inspections and team meetings, this demonstrates industry best practice.

Action G4: Submit reports required by the permit by the due date in the permit.

Action C2: Set up a system to ensure reports required by the permit are submitted by the due date. Personnel have been briefed, data sources reviewed and calendar reminders set up.

Actions A1, C1, C2 and G4 have been completed and can therefore be closed.
