BREACH OF BIO-AEROSOL LIMIT AT LLANDDULAS COMPOSTING FACILITY**SCHEDULE 3 TABLE S3.2 of the permit specifies a bio-aerosol limit of 1000cfu/m3 for total mesophilic bacteria**

The permit limit for Mesophilic bacteria was exceeded on the 22/03/2022 at 12:00hrs. at SP2 and SP3 and SP4 as detailed in report 'Evaluation of Composting Bio-Aerosols at Llanddulas Composting Facility' by D&F Associates.

The readings were; **SP2 - 2583 cfu/m3, SP3 1333 cfu/m3 and SP4 6167 cfu/m3.**

The permit limit is; **1000cfu/m3**

These bio-aerosol emissions are breaches of permit limit and therefore a score of CCS3 has been attributed on this occasion.

Measures are in place through the agreed Compost Action Plan to address these issues. Any further improvements to actions to ensure a reduction in bio-aerosols especially when shredding or turning windrows should be explored monitoring should be continued as scheduled
