Quarterly monitoring of all emission points and parameters required by Permit Condition 3.3.1, Schedule 3, Table S3.1 was undertaken for the relevant reporting periods. All results for emission points A1, A2, A3, A6 & A38 were within the emission limit values specified by Permit Condition 3.1.2, Schedule 3, Table S3.1.
