Inspection was mainly focusing as general site awareness day and introduction as new site inspector.

- General tour of site that included food waste reception hall and asbestos storage area - no issues identified
- Observed the deposit of hard-core inert material that was heavily contaminated - further training required for site operatives as it was clear that this waste was going to be accepted by staff on site if there as no invention from site manager.
- No litter or debris around site - transfer station was very well organised and no amenity issues identified.

Please further routine inspection and audits will be the main focus with particular attention to waste handling procedures.
