We need more information about your application

Application reference: PAN-003806

Thank you for your application received on 13/11/2018.

We need to ask you for some more information before we can do any more work on it.
Please would you:

- Enclose a letter outlining the reasons that your information should be made confidential.
- Provide the home address of the operator. If this address is the same as the address of the sewage treatment facility, please could you confirm this.
- Confirm that a more accurate national grid reference for the site is ST 15599 85226, rather than the NGR provided in question 2c.
- Provide a site plan for your sewage treatment facility, as requested in question 4. Attached is a site map. Please could you annotate the map with the discharge point, sample point and the location of the infiltration system (if necessary).
- Indicate the maximum daily visitor numbers to the site. The maximum daily effluent discharge of 1.7m³ provided for question 5e is an average for a 6 month period and not a daily maximum.
- Provide us with answers to questions 5g, 5h and 5i. We require a national grid reference for the discharge point location, and another for the sample point location if this is different to the outlet point. You also need to indicate where the effluent discharges to in Table 2 (5i) and answer the relevant section.
- Confirm that the billing and invoice contact for question 11d is the same as the contact used in question 1b.

If you need advice about how to complete the form, please contact your local area office. Call 0300 065 3000 and ask to speak to your local area office or your site officer.

Please reply within 10 working days from the date of this letter. If we don't hear from you we must return your application and fee.

If you email or write to us please quote the application reference PAN-003806 on any correspondence and send it to the relevant address below.

When we receive the missing items we'll continue to check the details in your application. If there's enough there for us to begin the process of deciding whether or not we can grant your application we say the application is 'duly made' and we'll let you know this by letter.
