Environment officer Nessa Dearle completed a site inspection on the 21st of September 2018, to assess compliance with your environmental permit. I was met on site by site managers Dean and Kevin Humphreys' and consultant Phillip Rees.

Thank you for taking the time to meet me on site, to discuss your waste permit and show me around site. The site appeared tidy and well managed at the time of inspection. No breaches were recorded on site; however, advice and guidance is outlined below.

Notes

While on site it was noted that batteries from end of life vehicles were being stored in an open topped container. The end of life vehicles Directive outlines that car batteries must be stored in acid resistant, sealed, weatherproof containers. As discussed on site, please put appropriate covered containers in place for car batteries within one week of receipt of this car form.

On site, you discussed the changes in storage that have been put in place on site. The depollution bay and the WEEE storage area has been alternated. On inspection, it was clear that the change is suitable for the site and will not negatively affect activities. However, the sites environmental management system will require an update to reflect these changes, this should include an updated site plan.

You have made NRW aware that your WAMITAB has expired. However, you have rebooked your WAMITAB test. In the meantime Phil Rees, a WAMITAB holder has visited site to cover your site competent until a new certificate is achieved. However, in future please ensure that you monitor the expiry dates of your technical competence and receive organize a new test prior to your current certificate expiry. Please send a copy of your new certificate once you receive this.
