Officers Nessa Dearle and Lisa MacDonald completed a site inspection on the 3rd of July 2018. The aim of this visit was to assess compliance with the environmental permit and assess the proposal that you have put in place to dismantle WEEE under a T11, to produce waste metal for shredding under your permitted process. We were shown around site by consultant Phil Rees and site managers Dean & Kevin Humphreys.

Thank you for taking the time to show us around site. The site appeared well managed at the time of inspection, however some minor issues were detected onsite. Advice and guidance is outlined below.

Notes

During our inspection, oil contamination was noted under one of the skips, close to an interceptor drain. We were advised on site that a spill had occurred that morning. It was clear that an effort had been made by staff to clear this spill, however, some residual contamination had been left behind. Please ensure that staff thoroughly inspect an area following a spill to ensure that all contaminants are effectively cleared.

On site we discussed the requirements for battery storage, as it was noted that batteries were being stored in open topped containers under cover. Table 2.1 of schedule 2 of your permit outlines that "Lead acid batteries shall be stored in containers with an impermeable, acid resistant base and a lid to prevent ingress of surface water". As such please ensure that all lead acid batteries are stored in sealed containers.

Thank you for going through your new proposal on site, it was useful to see how the process would work. I was happy with the proposal outlined to us on site and I am satisfied that you can produce metal wastes under codes 19 12 02 and 19 12 03, from the process. Providing that all requested information is submitted, you can now proceed with the T11 application process.
