S2 exemption

There is an S2 exemption on site which covers the storage of WEEE but the storage conditions are not being fully complied with and exempt waste was being stored mixed in with waste covered by the permitted facility. Please see the eCAR form attached which covers the exemption in more detail.

Waste transfer notes

Condition 4.2.2 states that 'A summary report of the waste types and quantities accepted and removed from the site shall be made for each year. It shall be submitted within one month of the end of the year'.

Natural Resources Wales have not received any waste returns from you for 2014. This is due to the fact that you have been sending them to the old Environment Agency address and they have not been passed on to us. As discussed please use the following email addresses going forwards:
