There is an annual subsistence charge for your permit. The annual charge is due on demand in the year that we issue the permit and then on 1 April each year. The charge starts from the date we authorise the permit, unless there's a condition relating to a standalone water discharge which states a later start date for the discharge. In that case we will charge for the discharge from the start date.
