Bio-Aerosol Monitoring – 20th October 2015

Bio-aerosol monitoring was conducted by Cardiff Metropolitan University on 20th October 2015. Thank you for submitting the results in a timely manner.

In conclusion, the CHSE / Cardiff Met completed ambient air monitoring of bio-aerosols in accordance with Association for Organics Recycling approved methodology. During monitoring, windrows in the quarry area were turned.

Bio-aerosol levels recorded during the monitoring exercise on 20th October 2015 were below the appropriate levels set by the Environment Agency, at all locations monitored.

Concentrations for all the micro-organisms measured downwind were below guidance levels suggested by the Environment Agency.

Concentrations of micro-organisms measured at the nearest receptor to the work in the quarry, Gelliargwellt Farm house, were also below guidance levels. The sensitive receptor was upwind of the activities in the quarry during the sample. Bio-aerosols may have come from several adjacent sources (IVC building, farm slurry tanks and cattle sheds).

The results of the monitoring indicate you are compliant with Condition 3.5.1, referring to Schedule 3, Table S3.1 of your permit.
