Introductory note

This introductory note does not form a part of the notice.

The following notice gives notice of the variation and consolidation of an environmental permit.

This permit variation adds some additional waste codes to the list of permitted wastes accepted at the facility. The permit consolidation will modernise the permit and the extended site boundary will incorporate the waste transfer station operations which are currently permitted along with the three waste exemptions for the storage and reclamation of soils, wood and construction and demolition waste. In addition the permit allows the composting of biodegradable material. The maximum permissible quantity of waste to be accepted at the site shall not exceed 150,000 tonnes per annum.

The schedules specify the changes made to the permit.
