Site inspection by regulating officer Geraint Richards. The weather was dry and sunny, I met Tony Parsons, the site operator who accompanied me around the site.

Breaches

No breaches have been scored against the operation of the site during this inspection. Please see the comments under 'observations' below for further information

Observations

You were breached on my previous inspection form under the permit condition for site management due to inappropriate storage of skips next to the reen, which is a designated protected watercourse. During this inspection I saw no waste material or skips containing waste stored next to the reen, thank you for addressing this problem by removing these skips. There is no condition in the permit specifying how you should store your empty skips.

The yard appeared in order, and the storage and segregation of waste materials was good. Please ensure you keep the drainage channel at the front of the concrete pad clear of materials so that it drains correctly to the sump.
