Officer Jonathan LEE completed a desk-based audit of waste returns for permit number EPR-WP3495FF, an end of life vehicle permit at Cardiff Arms Salvage, Curran Embankment, Cardiff, CF10 5FX.

Cardiff Arms Salvage have failed to submit annual waste returns for 2014,2015,2016 and 2017. This is a requirement of your permit as shown below:

Summary records of wastes accepted and removed

- 6.1.2 A summary of the waste types and quantities accepted and the waste types and quantities removed from the site shall be made for each financial year and shall be submitted to the Agency within 1 month following the end of that year. The summary record shall be in the format specified in Appendix A, and shall include the specified information.

Whilst a recent site visit by officer Jonathan Lee on the 30th April 2018 indicated that the site is undertaking minimal ELV operations, retrospective waste returns will still need to be completed to comply with the permit currently active for the site. It should be noted that in years where no ELV waste operations have been completed, a nil return should still be submitted to Natural Resources Wales.

On this occasion, the failure to submit waste returns has incurred a category 4 breach. Waste returns for years 2014, 2015, 2016 and 2017 will need to be submitted. Guidance on completing your waste return, alongside a blank copy of a waste return can be found at the link below:

Moving forward, appropriate procedures should be implemented to ensure reports are submitted on time. Annual returns should now be submitted for the annual return period by January 31st of the following year. For example, your 2018 return should be submitted by January 31st 2019.
