WARNING

On the 14th May 2018 my colleague and I carried out a routine inspection to check compliance with your permit conditions.

Following our discussion you submitted your daily flow data (as requested) which confirmed non-compliances with your permit condition. The condition states: 5. Volume The volume of discharge shall not exceed 45 cubic metres per day therefore this Compliance Assessment Report contains a **WARNING**.

It is an offence under the Environmental Permitting (England and Wales) Regulations to breach permit conditions.

The level of our enforcement response has taken into consideration the fact that you immediately instigated a permit variation which included sampling and analysis of all components used within your facility. The analysis showed that the increased discharge volume would not cause a detrimental impact on the receiving watercourse.

As of 5th December 2018 your varied permit was issued with the following conditions:
