Breaches

A1 - Specified activities; breach of condition 2.1.1:

"Waste shall only be deposited, stored, treated or otherwise handled in any area of the site, where the engineered site containment and drainage system for that area is provided in accordance with conditions 2.1.2 and Table 2.1 of condition 1.2, and in accordance with section 2.8 of the working plan."

Waste is stored outside of the permit boundary, where it does not benefit from the sealed drainage system.

Category 3 breach scored

C4 - Management - Storage, Handling, Labelling & Segregation; breach of condition 1.1.1;

"No waste management operations shall be authorised by this licence unless: a) specified in and undertaken in accordance with the limitations in the following table [...]"

More waste stored onsite than permitted volume of 80m³

Category 3 breach scored

A skip of mixed waste was stored outside of the site boundaries upon arrival. Waste must be stored onsite, where it benefits from a secure location and sealed drainage. Waste stored outside of the site poses a greater environmental pollution and vandalism. In addition to this, waste stored outside of the site is likely to attract complaints from local residents.

The volume of mixed waste was up, with waste above the height of the push walls and outside of the bay. However significant efforts were being made to reduce the volume of rubble and soil waste stored in the next bay. Please ensure that the amount of mixed waste is reduced in volume to manageable levels.

The majority of operations on site were related to associated scrap metal activity.
