Within the draft MP9 Bioaerosol Site Specific Risk Assessment V1 submitted by your consultant it states.

Current Environment Agency guidance<sup>3</sup> takes a similar stance with respect to the distance from a source within which bioaerosol impacts can be expected indicating that:

*"If your facility is within 250 metres of a sensitive receptor (a place where people live or work for more than 6 hours at a time), you must:*

- *monitor bioaerosols using M9: environmental monitoring of bioaerosols at regulated facilities*
- *do a site specific bioaerosol risk assessment"*

Within the Bioaerosol Risk Assessment it states that there were no sensitive receptors within 250m of the composting activity. This is incorrect as there is a domestic property within 250m of the composting activity. Please can you reassess and submit your MP9 Bioaerosol Risk Assessment.
