You are non-compliant with your licence.

We are currently considering taking enforcement action against you for the non-compliance recorded above. We will contact you in due course.

4. Details of our assessment

On the 14-03-22 Natural Resources Wales carried out a routine inspection on the hydro-electric scheme (HEP) on the un-named tributary of the Mochdre Brook, Newtown, Powys. The licence holder was present during the site visit.

The visit was undertaken to assess compliance of the HEP scheme in relation of the abstraction licence MD/054/0001/071 and the impoundment licence MD/054/0001/077.

Officers observed that the fish easement had not been constructed downstream of the weir as documented in the licence.

Proposals have now been submitted to NRW for fish easement structure to be reviewed. Confirmation will be given as soon as possible. Once approved you have confirmed works will be carried out and completed by the 01-08-22.

Following construction please provide photographic evidence to show easement structure.

Natural Resources Wales are now considering enforcement action as discussed. NRW will be in contact with you shortly.

Please note - NRW can refer cases of non-compliance to OFGEM where a hydropower operator is receiving Feed in Tariff (FiT) payments. OFGEM can consider withdrawing or suspending FiT accreditation where a Licence Holder is or has been operating in breach of licence conditions. This means there is a risk that FiT payments may be temporarily withheld or permanently stopped.

Should any further breaches occur NRW may consider informing OFGEM.
