Introductory note

This introductory note does not form a part of the notice.

The following notice gives notice of the variation and consolidation of an environmental permit.

This variation and consolidation is to increase the quantities of waste that can be accepted at the site, include additional waste codes, increase the permitted area and to modernise the permit to current standard conditions.

The maximum quantity of waste accepted at the site increases from 5,000 to 13,163 tonnes per annum.
