THIS IS AN INTERMEDIATE COMPLIANCE ASSESSMENT REPORT PENDING FULL SITE AUDIT.

It was evident that the operation is in a poor state; there is a significant stockpile of crushed end of life vehicles and whole end of life vehicles. During the site inspection it was noted that there were a number of areas covered with waste oil spills. There was no evidence to suggest that ELV's were being depolluted in accordance with Schedule 5 of the End of Life Vehicles Regulations 2003, furthermore it was noted that a number of ELV's contained oils, oil filters. Furthermore, there is a fire risk posed by the significant volume of ELV's, scrap and mixed waste materials stored at the site.

ELVs on impermeable surface not served by sealed drainage

Category 3 breach of condition Table 3.1(c) of licence – scored under B4 (Infrastructure – Containment of stored materials)

All vehicles stored on hard standing must be de-polluted.

Oil spills evident throughout the site

Category 3 breach of condition 5.1.4 Table 5.1 (d) Control and remediation of leaks and spillages states; (I) Minor spillages of oil, fuel or other end of life vehicle fluid shall be cleaned .

It was evident that the multiple oils spills had not been attended to and no spill kits were available when challenged.

ACTIONS

Ensure that all vehicles have been de-polluted and processed in accordance with schedule 5 ELV Regulations.

Clear all oil spills and replace spill kits.

FIRE RISK

Due to the significant fire risk posed by the operation; namely high volume storage of mixed waste and ELV storage without fire breaks. NRW will now consider what intervention (including formal action) is required.
