Introduction

Site Audit carried out by Ella Williams looking at the de-pollution process for the end of life vehicles in line with Schedule 5 of the End-of-Life Vehicle Regulations 2003.

Met with Ashley Griffiths on site. Weather dry, warm and sunny at time of visit.

Breaches

No breaches were noted during the de-pollution process. Please see comments below under "observations".

Observations

De-pollution of a Citroen Saxo done on rig under cover on the top part of the yard which is on impermeable surface with sealed drainage.

Vehicle did not have air-conditioning but de-gassing equipment was witnessed as present on the site. Airbags are removed whole to be re-sold, if not sold, there is detonation equipment available on site. All fluids, batteries, wheels and weights removed and put into labelled containers.

Consignment notes required under the hazardous waste regulations 2005 were also checked and found to be compliant.

Previous CAR form

Breaches noted on the last visit have been rectified:

- Only de-polluted vehicles and non-waste vehicles stored in bottom yard. This area is not served by the sealed drainage system and therefore ELVS that have not been fully de-polluted cannot be stored in this area.
- Drainage channel has been repaired.
- All storage containers were found to be labelled and in compliant storage areas
