Breaches recorded

C4 – Storage, handling, labelling and segregation. Category 3 breach.

Condition 1.1.1 states that the operator shall manage the operation in accordance with a written management system. The working plan states that asbestos will be double bagged in plastic sheeting upon receipt and locked up in a container. The public will not be allowed to access this according to the plan.

Whilst on site we saw that asbestos is not double bagged and is left outside in a builder's bag throughout the day. We were told that this was the normal procedure and it is moved to a second site in the evenings. This can cause health problems as well as environmental issues, with members of the public at risk of coming into contact with it.



Action: Please ensure asbestos is double bagged and secured in a container as stated in the working plan.

Other comments

There was WEEE stored outside in various places without any cover from the rain. The working plan states that they will be in a designated area covered with tarpaulin. According to Annex III of the WEEE directive, it can be stored outside providing it is for disposal and not for recycling or repair. Please ensure it is stored inside if this is not the case.

The working plan states that paints and other household chemicals will be stored in a lockable, bunded, chemsafe unit. Whilst on site we saw that they are stored in waste bins which have no secondary containment. You may want to consider storing paints in a secure container with secondary containment in case of any incidents.

Commercial vans could be seen on the premises unloading waste into the designated skips. We were told that vans are now permitted on site providing they have authorisation from the council. Should these vans contain commercial waste and not householder waste as stated, the duty of care will need to be followed. The duty of care applies to anyone who receives, produces or transports commercial or business waste which includes the need to classify the waste and complete waste transfer notes.
