#### 4. Details of our assessment

This is my first visit to the site (LW). I met Simon Morris (General Manager) who has recently returned to the site. Simon is also the TCM at the site.

Dave Ellar undertook the previous inspection in 2021 where there were some concerns regarding the non inert waste being stored off the impermeable pavement. At the time of inspection all non inert waste was stored within the building on an impermeable pavement.

There were also concerns about the height of the wood waste and it's proximity to the boundary fence. During the inspection there were no concerns about these issues, the wood pile was now held in concrete bays and away from the site boundary.

I confirmed that Simon Morris had his continuing competency certificate up to date. This expires on the 23/02/2024 and is for TSH, TSNH and TMNSH awards.

I requested the drainage map that Dave Ellar had previously asked for. This has been forwarded within the last week and can be found on the site file and is also attached to this report. The drainage plan confirms that all runoff within the building goes to a leachate holding tank. The green waste and wood waste storage area is on impermeable pavement and drains via a silt trap to soakaway.

LW discussed the issues with consignee returns and the need for the site to be up to date. It is important, even if there have been no movements of hazardous waste, that consignee returns are completed. There was one consignment note raised last year for the removal of fridges. These went to Simms in Newport. The consignment note is attached. This issue has now been resolved. The site is a registered premise with the code CAB253 which expires on the 6/3/23.

The site appeared well run with good housekeeping.
