3. What will happen next?

Any non-compliance we have identified and recorded on this form is an offence. It can result in criminal prosecution and/or suspension or revocation of your permit.

4. Details of our assessment

Forms W1, Emissions to Water and S1, Emissions to Sewer, for 1st January to 31st March 2022 were received on 19th April 2022.

The reports are accepted.

W1 Emissions to Water

All parameters were within their respective emission limit values (ELV).

S1 Emissions to Sewer

Flow and pH were within their respective ELVs.

Aluminium (Al) emissions to sewer exceeded the ELV on 4th January 2022. The ELV is 2mg/L and the Al concentration was measured as 9.5mg/L. A Schedule 5 Notification was submitted and CAR_NRW0039156 required AIUK to complete several corrective actions by 31st January 2022.

Natural Resources Wales (NRW) have not seen any evidence that the following has been completed -

"Action B5: Identify HCl dosing lance as critical equipment. Review and amend planned preventative maintenance programme. Send results to NRW by 31/01/2022."

In NRW's view AIUK therefore remain in non-compliance and so have been issued with a Category 3 non-compliance for the lack of planned maintenance for the lance and a Category 4 non-compliance for exceeding the Al ELV.
