We are currently considering taking enforcement action against you for the non-compliance recorded above. We will contact you in due course.

4. Details of our assessment

The non-compliances listed above were identified during our annual 2021 data audit. This audit assessed Dwr Cymru Cyfyngiedig's compliance at all their sewage treatment works and water treatment works with Operator Self Monitoring (OSM) conditions, UV conditions (only applicable at some sewage treatment works) and Urban Waste Water conditions (only applicable at some sewage treatment works).

Non-compliance dated 24/12/2021: Dets Temp, BOD, Ammonia, Suspended Solids, Aluminium and Iron for sample date 25/05/2021 was submitted late on the 24/12/2021.

Non-compliance dated 29/07/2021: UWWTD samples taken on 11/06/2021 and 19/06/2021 were submitted one day late.

Our enforcement response is subject to further investigation.

Please note: This CAR is dated 31/12/2021 as these non-compliances relate to annual 2021 data, however for clarity, I carried out the compliance assessment on the 22/04/2022.
