4. Details of our assessment

Waste returns were received via email on 20th April 2022 in compliance with the timeframe required by Permit Condition 4.2.5.

The *Waste_Removed* tab of the spreadsheet indicates that 157.66 tonnes of waste with the EWC code 19 12 12 waste sent for recovery by the route *R10 Land treatment resulting in benefit to agriculture or ecological improvement* to a local authority area in Manchester. A review of 2021 waste returns indicated that a waste transfer with the same descriptors is listed in the Q4 2021 waste returns.

Action: Submit copies of the waste transfer notes for all transfers of the 19 12 12 EWC coded waste stream destined for recovery by R10 land treatment that was transferred to the recipient/s in the Manchester local authority area in Q4 2021 and Q1 2022.
