Environment Officers Alice Sims and Lara Moggridge attended an on-site, office meeting to Lamby Way (Permit number - **EP3995FL**), with a particular focus on the Exports Inspection Checklist.

Officers Sims and Moggridge met with Martin Williams and Victoria Thorne to discuss how the Chinese export restrictions have affected the site. It was established that the site exported waste indirectly to China, via their customers. The main waste stream that was exported was papers and small amounts of plastic.

Other countries of final waste destination included Indonesia, Germany, India and the UK. It was stated that they plan to deal with the Chinese restrictions by negotiating alternative destinations for waste streams to go, including more UK sites.

The main issue that has arisen from the export restrictions is a reduced buying price for recycled paper. The site has even needed to pay for removal of G1 and G2 paper as they have failed to find buyers for these grades. In addition to the reduction in value, other impacts include saturation of materials in the UK and EU market, stockpiling and job losses.

Mr Williams ensured that very little stockpiling occurs at Lamby Way as there is only a small amount of space available and they prefer that waste streams are removed as quickly as possible. The approximate maximum tonnages of material stored on site at one time is 60 tonnes of paper and 600 tonnes of plastic, all of which is baled.

At present, there is no fire condition within the permit. However, the future implementation of one on site was discussed.
