Breaches

C4: Management - Storage, Handling, Labelling & Segregation - breach of condition 1.1.1 (management system point 4.11); & 2.1.1 (Schedule 2, table 2.1);

1.1.1 "The activities shall be managed and operated:

a) in accordance with a management system, which identifies and minimises risks of pollution, including those arising from operations, maintenance, accidents, incidents and non-conformances and those drawn to the attention of the licence holder as a result of complaints."

2.1.1 " The licence holder is authorised to carry out the activities specified in schedule 2, table 2.1 ("the activities").

All bulking or transfer of non-hazardous waste must be carried out inside a building."

Mixed waste stored on the concrete pad - Activities on the composting area not being managed in-line with management system.

Point 4.11 of your management system states that any wastes other than the two streams accepted for composting will be 'turned away'.

Category 3 breach

F3: Amenity - Dust/Fibres/Particulates & Litter - breach of condition 3.2.2;

"Litter or mud arising from the activities shall not cause pollution. The Licence holder shall not be taken to have breached this condition if appropriate measures have been taken to prevent or where that is not practicable, to minimise, the litter and mud."

A lot of litter on site, including in and around the reen.

Mixed waste including light weight wastes stored up against estuary boundary on composting pad, allowing litter to easily blow off site boundary.

Category 3 breach



Waste transfer station

The waste transfer station contained mixed general waste from commercial sources and the Vale of Glamorgan, and food and black bag waste from Cardiff's collections. Some plasterboard was stored here. There was also a pile of street sweepings stored at the far end of the permit. The street sweepings were contaminated with plastic bottles and other material, and were going to be further treated at a soil wash. Whilst you can accept street sweepings, these street sweepings appeared to be being de-watered at the Waste Transfer Station, which isn't an activity covered by your permit - if this is to be a long term activity then you may need to consider varying the permit to include this activity.

Material Recovery Facility

The materials recovery facility was in operation with stockpiles of un-processed waste generally low. The facility will typically process around 140 tonnes a day, provided there is no plant or machine down time, or other delays. Facility generally produces two different grades of materials, with low contamination levels within grade 1, and higher contamination in grade 2. Some of these grade 2 materials, such as grade 2 LDPE go straight to the Energy from Waste plant, where as other grade 2 materials go to other facilities for further processing.

Outside of the facility the waste fines are stored in a bay. These appeared to be attracting a lot of pests, such as seagulls, due to the organic content. There was a lot of litter around in this area, including litter that had been blown into the reed/large ditch that runs through the site, and connects to the outfall on the Severn Estuary. There were little measures to prevent this litter being blown away, and once it has been blown into the water it is tricky to remove. Staff will clean up after every shift, but greater measures may be required to prevent litter being blown away.



Composting area

A lot of green waste was being stored at the composting area, some of which appear to have been composted. There was also a significant amount of mixed waste stored on this pad. None of the staff onsite were able to explain why this waste had been stored here. Mixed waste stored in this area is not compliant with your permit. Under schedule 2, table 2.1 all non-hazardous waste pending recycling or disposal must be stored within a building with sealed drainage or a sealed container. By not storing this waste in the building, there is no control over emissions. Litter was seen being blown off the yard into the Severn Estuary.



There was also a large pile of mixed hard plastics and inert waste stored on this part of the yard. Please be aware that the waste here needs to be cleared before the permit for the composting transfers over.
