Points A1, permitted activities, C4, Storage, handling, labelling and segregation, F1, Odour, F2, Noise and F3, Dust, fibres and particulates were considered during the inspection.

There was significant site improvement being undertaken at site at time of inspection, this will improve both infrastructure and safety on site. This inspection was an interim inspection to discuss waste wood and plastics and view on going structural improvement of the site.

It was noted that the stockpiles of both wood and plastics were well within permitted volumes.

There were no permit breaches identified at time of visit.
